**EXHIBITOR'S AGREEMENT**

The \_\_\_\_\_ hereafter to be known as an Exhibitor, must agree to the following rules and regulations upon acceptance of the space assigned M.C.A.S.D. at the \_\_\_\_\_

- 1. - Exhibitor will be responsible for loading and unloading their wares to and from their designated area, and retain such wares within their assigned boundaries. If, upon inspection by fire inspectors, any infraction of fire ordinances are found, Exhibitor must conform to same, without recourse to the M.C.A.S.D. We, the M.C.A.S.D., shall of course attempt to conform to all fire ordinances at set up, but we are in no way experts in this field.
- 2. - Exhibitor's arrival time for set up shall be no earlier than 12:00 p.m. on \_\_\_\_\_ Designated Exhibitor's areas to be indicated to Exhibitors by M.C.A.S.D. personnel before Exhibitor set up is initiated.
- 3. - Exhibitors shall have their designated area clear of all wares and left in an orderly condition by 6:00 p.m.
- 4. - No nailing of partitions, signs, display boards, etc. or other defacing of walls, ceilings, floors or windows will be permitted.
- 5. - In all fairness to other Exhibitors, no complete closeout of Exhibitor's wares, going out of business sales or advertising of same, in the Convention Program will be permitted.
- 6. - Vans, trailers, trucks, or other vehicles used to transport Exhibitor's wares, will not be permitted to park near entrances; immediately upon unloading they must be removed and parked in an area designated by M.C.A.S.D. personnel.
- 7. - Exhibitors should bring their own display racks and materials. If you require additional lights or extension cords you must supply your own. Extension cords will not be permitted to run across traffic areas. Accessibility to additional lighting cannot be guaranteed.
- 8. - *added to contract* \* If Exhibitor cancels less than 4 weeks before scheduled MCASD event, fee paid by Exhibitor is not refundable.
- 9. - M.C.A.S.D. will do everything possible to prevent any loss of wares due to theft, but cannot assume responsibility for same.
- 10. - Please sign and return this Agreement with registration form.
