Once again, it is time for MCASD Clubs to renew their MCASD membership, report their Delegates to the MCASD Board of Directors for fiscal year 2023-2024, and apply for renewal of club membership and their liability insurance coverage for 2023-2024, as needed.

There is no Venue for the State Square Dance Convention at this time. There have been several Convention meetings. In 2024 a special State dance is being planed in July. Keep in mind square dancing at the Illinois State Fair will be held be this year in August. Watch for information on getting free tickets for admission and free parking.

Without the State Square Dance Convention no club could purchase liability insurance for <u>only</u> \$20 (Normally \$35). We will let you know when it returns to normal.

At the MCASD Board meeting March 16th, 2019, A motion was made to reduce Dues and Insurance for clubs with 15 or less members. Dues \$5.00 & Insurance \$5.00. Clubs with 16 or more members will be Dues \$40.00 and Insurance \$20.00 (Normally \$35).
